

WKLT/WKLZ Radio Station Rules: Dr Pepper / Walmart Talent Search 2010

1. WKLT/KLZ will prequalify 23 Walmart patrons to compete in each participating store's talent search. The Vocal Talent Search registration information is posted at the Dr Pepper/7UP displays inside participating Walmart stores and announced on WKLT/KLZ.
2. All participants in the vocal talent search must bring their own karaoke cd to perform with; Music Type to Perform: Country, Top 40, Rock, Classical, Contemporary, (No Rap or Heavy Metal).
3. Each participating store talent search will render a finalist. That finalist will be invited to the finale and will be notified within 24 hours of the talent search date in which they competed to become a finalist.
4. Date and time of the finale will be on or about March 24, 2010 at the Traverse City Walmart Store and the grand finale winner will be announced live at the finale.
5. All finalists are guaranteed a prize, with the grand finale winner winning a trip for two to Las Vegas and tickets to the 2010 Academy of Country Music Awards in Las Vegas, April 16 - April 19.
